L.I.T.E. 2021 Information

We are once again offering your 13 or 14 year old teen a different kind of summer camp experience with L.I.T.E. or Leader In Training Experience! Here is a chance for your teen to learn valuable leadership skills and gain experience working with children. As a LIT, your teen will become part of our counselor team as an assistant to the adult staff. While they will still be involved with the daily activities, it will be in a different role than a PrimaryZone or SecondaryZone camper. They will assist with planning games, monitoring campers, organizing equipment, leading activities, etc. This experience can help foster personal growth as they become role models for the younger campers.

Please note the 2021 information highlighted in dark red below.

- Registration will be accepted on a weekly basis.
- All L.I.T.E. participants will be required to enroll in a minimum of **four weeks**.
- Registration fees will be \$100 per week and will be split into 2 payments. A \$50 deposit will be required for each week registered with the remaining balance due by May 24th. Week 5 will have reduced enrollment fees.
- Resident rates apply to residents of: Lemoyne, New Cumberland, Goldsboro & Lewisberry Boroughs and Fairview & Lower Allen Townships.
- The only LITE registrations I will be accepting will be from teens like yours that were enrolled in the 2020 Summer that was cancelled.
- **All LITs will be required to attend a mandatory training meeting on June 1st in the evening.** Meeting time will be 6:30-8:30 pm. LITE enrollees who miss this meeting may be from the program (refund fees will apply).
- Each LIT will receive t-shirts to wear as a staff member.
- All field trip admissions are included.
- A bag lunch, snack and water bottle should be brought daily.
- A modest swimsuit will be required for swimming days.
- Participants will be assigned to a PlayZone site at **FCES** (Primary or Secondary) that they will assist at for that given week. This site may vary from week to week based upon how many LITs are enrolled and where they are the best fit as determined by the Recreation Manager. **Week 9 will be held at Fishing Creek Salem UMC (402 Valley Rd, Eters).**
- **Expectations will be high in terms of personal attitude and behavior, willingness to help, desire to be enrolled, ability to adhere to camp rules and follow the direction of the adult staff at all times. Participants will need to continually meet these expectations as determined by the PlayZone adult staff and the Recreation Manager. Participants will no longer be considered just a "camper", but a contributing staff member. L.I.T.E. participants will be refunded from the program should the teen not meet these expectations (refund fees will apply). Teens should have a personal desire to be enrolled and display this throughout the summer. Please be sure your teen understands and accepts these requirements prior to enrollment. If the teen is forced by a parent or guardian to attend, the program is not a good fit for them.**
